From I-385 North:

I-385 North to **Exit 27** (Fairview Road). At the end of the ramp, at stop light, continue straight onto South Street.

Pass McDonalds (the road forks, continue straight). Go about one mile to turn left onto W. Curtis Street.

The Simpsonville Activity & Senior Center will be directly on your right.

From Greenville / Atlanta / Charlotte and I-385 South:

Take I-85 to I-385 South to **Exit 31** (Highway 417). Turn left onto Highway 417 toward Simpsonville.

Go about 2.5 miles, turn right onto W. Curtis Street (by brick clock tower), cross RR tracks.

The Simpsonville Activity & Senior Center will be about 1/4 mile on your right.

Alternate directions from I-385 North or South:

Take I-85 to I-385 to **Exit 29** (W. Georgia Road), then head east. Turn right onto N. Industrial Drive,

then left onto W. Curtis Street. The Simpsonville Activity & Senior Center will be about 1/2 mile on your left.

Veterinarians in the area:

Saturday morning: Hillcrest Animal Hospital, 864-967-7387, 1211 E. Georgia Road, Simpsonville, SC 29681. Directions: Left on W. Curtis St, follow 3.8 miles. Curtis Street becomes E. Georgia Rd; continue on E. Georgia Rd to vet.

Evenings & weekends after noon Saturday: Greenville County Veterinary Emergency Clinic 864-232-1878, 393 Woods Lake Road, Greenville, SC. 29607. Directions: Turn right on W. Curtis St, turn right on Frontage Rd, turn left at W. Georgia Rd, immediately on the right take the entrance to take I-385 North. Follow to exit 39, turn left on Haywood Rd, turn at the first right onto Congaree Rd, turn right on Woods Lake Rd. Veterinary Clinic is on the right.
