Procedure Guidelines for 9/12-9/13 2020 Rally Trials

Do not expect this Trial to be as all the others you have attended in the past.

1. The Check-in Table will be located outside near the front entrance where Arm band number(s) will be picked up at this table.
2. **Mask are required in the building!** Social distancing required **inside** and **outside** the facility.
3. An **Enter only** and **Exit only doors** will be clearly labeled. One-way movement will help flow.
4. To expedite our process during this pandemic Course maps will be **emailed** out to all exhibitors at 6 pm on Friday (for Saturday) and 6pm Saturday (for Sunday).
5. Exhibitors for walk throughs will line up 6 ft apart and will go in the ring at appropriate intervals to navigate their walk throughs keeping safe distances.
6. Inside crating is **limited**. 6 X 6 spaces are will be available on a 1st come 1st serve basis.
7. **Rugs/Mats are required** under your crates and chairs.
8. **A label is required at your set up with Name and contact number.**
9. No electric / battery fans will be allowed in the building.
10. **Outside crating** will be available in a shaded tree area. A volunteer will be directing parking.
11. An inside Restroom facility is available.
12. Complimentary bottled water will be available as well as can drinks for \$1.00.
13. **Hand sanitizer stations** will be located throughout the facility.
14. **This event is closed to the public. This is due to Covid Restrictions.**

We are thankful for AKC and Piedmont Obedience Club for allowing DOCG to use this venue. We anticipate long days and possible obstacles during these new Covid directed trials. Flexibility is important for everyone involved. We want all exhibitors and Volunteers to be safe and have fun!

- Turn right onto Syphrit Rd
- Turn left onto Carver St, just past Astor St
- If you reach Brook St you have gone about .3 miles too far

From Charlotte

- Take I-85 South toward Greenville / Spartanburg
- Take Exit 66, US-29, toward Lyman/Wellford
- At the end of the ramp turn right
- Turn right onto Syphrit Rd
- Turn left onto Carver St, just past Astor St
- If you reach Brook St you have gone about .3 miles too far

From Columbia, SC

- Take I-26 West toward Spartanburg
- Merge onto US-29 South via Exit 21A toward Greer
- Turn right onto Syphrit Rd
- Turn left onto Carver St, just past Astor St
- If you reach Brook St you have gone about .3 miles too far

From Asheville, NC

- Take I-26 toward I-40
- Take Exit 10 SC-292 toward Inman
- Turn right onto Highway 292/SC-292 and continue to follow SC-292
- Turn left onto Bobo Rd. Bobo Rd becomes Carver St

No motor home parking allowed; no overnight parking allowed.
No dogs can be left in the building overnight.
