**Directions to the trial site**

Top Dog Training Facility 24 Bartley Road, Flanders, NJ 07836

**From Rt 80 East or West (exit 27A) to Rt 206 South:**

Go 4 miles, turn right onto Bartley Rd, just before the railroad overpass. Go about a mile to Top Dog on the right.

**From Rt 287 (exit 22B) to Rt 206 North:**

Take 206 through the town of Chester and cross the intersection of 206 and 24 / 513. Stay on 206 to the second traffic light and make a left onto Bartley-Chester Rd. Cross over the railroad tracks. Turn right and then make an immediate left to Top Dog.

**EXHIBITORS: There will be no exhibitor crating in the Top Dog training building, but crating will be allowed in the Top Dog Day Camp building next door. All crates should have a mat under them.**

**Top Dog Day Camp crating opens at 11 AM on Saturday and 7:30 AM on Sunday**

**You will be able to watch the rings in the Top Dog Building, but no chairs will be allowed. We will monitor the number of people and ask that you not congregate.**

**You will be able to warm up your dog in the Top Dog building prior to your run.**

**Masks: fully vaccinated individuals do not have to wear a mask inside, but masks should be worn inside if you are not vaccinated.**
