Jump Height is required for all obedience and rally classes with jumps.
Classes with jumps will run in **ascending jump height order**,
beginning with the lowest jump height in all trials. Exceptions to jump height
running order may be made for handlers with multiple entries.

Judges are not required to wait for dogs. It is the responsibility of the owner or
handler to have the dog at ringside when its class is called.

Refund for bitches in season less \$7 per entry with veterinarian's note.

All dogs present must be on leash or confined to a crate except when being
judged in the ring.

No unentered dogs inside building.

Directions to the trial site

Top Dog Training Facility 24 Bartley Road, Flanders, NJ 07836

From Rt 80 East or West (exit 27A) to Rt 206 South:

Go 4 miles, turn right onto Bartley Rd, just before the railroad overpass. Go about a mile to Top Dog on the right.

From Rt 287 (exit 22B) to Rt 206 North:

Take 206 through the town of Chester and cross the intersection of 206 and 24 / 513. Stay on 206 to the second traffic light and make a left onto Bartley-Chester Rd. Cross over the railroad tracks. Turn right and then make an immediate left to Top Dog.
