I-75 North. Exit 261—GA-280 toward Lockheed/Dobbins AFB. After approximately 3.2 miles, turn right onto Fairground St. SE. Glover St. will be approximately .25 miles on your left. If you get to the QT, you’ve gone too far.

**From the North:**

I-75 South, Exit 265 – GA-120 toward Marietta/White Water. Go almost a mile and turn left on Fairground St. NE. Glover St. will be approximately 1.4 miles on the right just pass the Marietta Civic Center & softball fields. If you get to Delk Rd./Lockheed, you’ve gone too far.

## **Trial Information and Entry Regulations**

### **Trial Hours**

7:00am—6:00pm Eastern Daylight Savings Time

- Building will open at 8am all both days
- **NO x-pens allowed.**
- **NO retractable leads permitted indoors**
- **NO strollers: dog or human**
- **REGULAR AND OPTIONAL TITLING ENTRIES LIMITED TO 8 JUDGING HOURS PER JUDGE PER DAY**

Indicate '**UDX**' and/or "**PUDX**" if you are entering both Open B & Utility B and/or Preferred Open/Utility and you want no entry if one class or the other is already closed due to entry limitations (Obedience Regulations: Chapter 1 Section 27).

**Refunds** will be given per AKC regulations and for entries withdrawn in writing or email before the closing date and time. \$5.00 of each entry fee is a non-refundable administrative fee.

4Paw will refund entry fees for bitches that come into season after the closing date of the trial less a \$10.00 administrative fee **per entry**; please submit a letter of explanation from your veterinarian along with your request for such a courtesy refund.

**No refunds** for errors on entry forms, or if a dog is absent, disqualified, or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.

**Confirmations/Judging Program** will be sent via email unless otherwise indicated.

**Changes** or corrections to entry forms must be received in writing or email prior to the close of entries. Entries are acknowledged via email as received. Entries are confirmed and the judging program is distributed via email when all entries are processed, final judging assignments are complete, and exhibitor armband numbers have been assigned.

**Obedience High Jump Height is required for all entries in classes with jumps. Obedience jump heights will be small to tall Saturday and tall to small Sunday.**

**Entry Fees** Make one payment for the combined total of all entries and pre-orders. Returned checks are not a valid payment of fees; the club will add a collection fee to any returned check.

**Transfers** will be accepted per AKC regulations if the class is not full. Completed and signed move-up form must be submitted to the Trial Secretary no later than **30 minutes prior to the start of the trial.**

**Show Site** will be open to exhibitors at 7:00AM.

**Exhibitors** should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**CLEAN UP** Exhibitors will be responsible for picking up after their dogs and maintaining clean conditions in and around their crates.

## **FRIDAY AND SATURDAY RING TIME WILL BE OFFERED!**

Friday is offered **ONLY** for Saturday competitors and Saturday is **ONLY** for Sunday competitors. \$10.00/10 mins.

Friday is 6:00-8:00; Saturday begins after the end of the trial. Please be sure to include phone number for text updates, but the judging program will be a good guide for the start.
