ATTENTION EXHIBITORS

Please read before entering!

By entering this trial, you are verifying that your dog possesses a current Rabies vaccination on the day of the trial. The well-being of volunteers, judges, participants and dogs is of paramount importance.

Covid-19 conditions that prevent RDOC from holding this trial will result in refunds. Extreme weather conditions such as but not limited to snowstorms, hurricanes, lightning, extreme heat/cold must be considered for the safety of everyone involved. In the event the trial is canceled due to extreme weather or halted due to extreme weather, no refund of entry fee will be made.

Should Local, State or Federal Covid-19 restrictions escalate, updates on day of trial restrictions can be found at www.rdoc.org Should Covid-19 restrictions escalate, crating will be from your vehicle. Signage will be utilized on doors should masks be required. By entering this trial, you agree to follow all Local, State or Federal restrictions.

Both the Main and Annex buildings are non-smoking buildings.

There is a bathroom in the Main building. The bathroom in the Annex/crating area is for handicapped exhibitors only. There will be two Port-a-Johns outside in the parking lot near the dogs' potty area.

Exhibitors may unload their cars to crate in the Annex beginning at 7 a.m. Saturday Feb 18 and Sunday Feb 19. After unloading cars should be moved across Tomlynn Street to the area marked EVENT PARKING.

Please **clean up after your dogs** – The dog potty area is the gravel lot across from the Annex. There are bags for you to clean up and a trash can for disposal.

DO NOT POTTY YOUR DOG IN THE MULCHED BEDS ALONG TOMLYNN STREET.
DO NOT ALLOW YOUR MALE DOG TO RELIEVE HIMSELF ON THE WALLS OR DOORS OF THE BUILDING.

Flexi-Leads are not permitted in the building. No dog whistles are permitted.

Unentered dogs will not be allowed in the Main building or the Annex.

ALL CLASSES – all dogs will be judged from low to high jump height for all classes, beginning with dogs whose jump height is 4 inches. Ring is 40' x 50'.

Entries without fees will not be accepted. Acknowledgement of entries will be made as soon as practical. Should such acknowledgement not be received by the exhibitor within a reasonable time, please notify the Trial Secretary.

Entries not made on official AKC entry forms, or photocopies of entry forms, without the agreement and rules of the official AKC entry form are not acceptable.

No entry shall be accepted which specifies any conditions as to its acceptance.

Entry fees shall not be refunded if a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Trial Committee.

No entry fee will be refunded in the event of errors or cancellation of entries after the published closing date.

Dogs may arrive approximately one hour prior to their scheduled time of judging. Dogs not required for further judging are excused. All dogs must be held on leash or confined to their crates except when being judged.

The Judge will not wait for any dog holding up a class. Owners or agents are responsible for the presence of their dogs for the judging ring when their classes are called to be judged.
