GCOC Trial Information and Procedures

- We will use both entrances to the building - the main lobby & obedience entrance doors are to the right, the ring 3 rally entrance doors are to the left, as you face the building from the parking lot.
- Obedience armbands will be available for pickup in the main lobby; then check in for your obedience class(es) at the ring in the main gym.
- Rally armbands will be available for pickup in the rally room, then check in for your rally class(es) at the ring.

- Building will not be open to exhibitors on Friday; Building will be open at 730 am - 630 pm on Saturday, and 730 am to 4 pm on Sunday

Directions to the Show Site:

Tri-City Leisure Center, 485 Brooks Avenue, West Columbia, SC 29169

From Spartanburg/Greenville via I-385S to I-26 E, & **from Charlotte** via I-20W to I-26E:

Take I-26E, Exit 111B. Merge onto US 1 N / Augusta Rd toward West Columbia. Turn right onto Dreher Road. Turn right onto SC-602 / Platt Springs Road. Turn Right onto Brooks Avenue. Tri-City Leisure Center will be on the left.

From Augusta via I-20E: Take I-20 E, exit 58 for US-1 N toward Columbia Airport / West Columbia, then turn right onto US-1 N / Augusta Rd. Pass I-26, then as above, turn right onto Dreher Road. Turn right onto SC-602 / Platt Springs Road. Turn Right onto Brooks Avenue. Tri-City Leisure Center will be on the left.
