Entries are acknowledged via email as soon as they are received and processed. Please review and respond right away if any changes are noted. Armband numbers are confirmed and judging programs are distributed via email for all entries. This will be shortly after closing, when final judging assignments are complete, and exhibitor armband numbers have been assigned. Premium lists for future trials will also be sent out via email.

Refunds will be given for entries withdrawn in writing or via email before the closing date and time. POTC will give full refunds per AKC regulations for bitches that come into season after the closing date of the trial, and for no other reason. You must submit a signed statement of the dog's condition from your veterinarian on his/her office stationery along with your request for such a refund to the trial secretary at least 30 minutes before the start of the trial.

No refunds for errors on entry forms, or if a dog is absent, disqualified, or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.

Changes or corrections to entry forms must be received in writing or via email prior to the close of entries. Indicate '**UDX**' (**OB/UB**), '**PUDX**' (**PO/PU**), '**RAE**' (**AB/EB**), '**RACH**' (**AB/EB/Master**)' if you want no entry if one class is already closed due to entry limitations.

Obedience High Jump Height is required for all entries in classes with jumps. **Rally Jump Height** is required for all entries in classes with jumps..

Entry Fees must be paid with entry submission for online entries. If a check is returned, we will add any bank fees to the amount due.

Transfers will be accepted per AKC regulations if you have earned a new title after closing, and if the class is not full. The fee difference will apply for transfers from a non-regular to a regular class. Completed and signed transfer form must be submitted to the Trial Secretary no later than **30 minutes** prior to the start of judging for the trial.

All dogs must be held on leash or confined to crates, except when being judged or in designated warm-up areas. No Flexi leashes or prong collars permitted in the buildings. No ex-pens in the buildings.

No camping permitted at the show site. No overnight parking.

POTC assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. For safety reasons, no strollers are permitted in the building during show hours.

- Approaching Spartanburg on I-26W
- Take Exit 22 toward Spartanburg (SC-296/Reidville Rd)
- Merge Right onto John B White Sr Blvd
- Continue 1 Mile; Holy Communion Lutheran Church on Left

From Charlotte, NC

- Approaching Spartanburg on I-85S
- Take Exit 70 toward Columbia, SC
- Merge onto I-26E and continue 4.5 Miles
- Take Exit 22 toward Spartanburg (SC-296/Reidville Rd)
- Keep left at top of ramp toward Spartanburg
- Merge left onto John B White Sr Blvd
- Continue 1 Mile; Holy Communion Lutheran Church on Left

From Greenville, SC

- Approaching Spartanburg on I-85N
- Take Exit 66 toward Spartanburg West/Wellford
- Merge onto US-29N toward Spartanburg and continue 4.25 miles
- Merge onto I-26E toward Columbia
- Take Exit 22 toward Spartanburg SC-296/Reidville Rd)
