#### **CRATING**

No crating in the building except for stewards. Crating out of your car only.

#### **AIRING DOGS**

The building is adjacent to the Cobb County Civic Center Sports facility, so there is plenty of green space to walk dogs. Please remember to pick up after your dogs.

#### **PARKING**

In addition to limited parking in front of the building, there is a parking pad in the Cobb Civic Center Park. This is extremely convenient to the building, within 50 feet. Take the second driveway on the right to park here.

On Saturday and Sunday, you may park in front of the businesses to the left of Alchemy. DO NOT BLOCK THEIR GATES! You may also park behind those who are parked at the Alchemy gates.

I-75 North. Exit 261—GA-280 toward Lockheed/Dobbins AFB. After approximately 3.2 miles, turn right onto Fairground St. SE. Glover St. will be approximately .25 miles on your left. If you get to the Quick Trip, you've gone too far.

#### From the North:

I-75 South, Exit 263 – GA-120 toward Marietta. Go about a mile and turn left on Fairground St. NE. Glover St. will be approximately 1/4 mile on the right just pass the Marietta Civic Center & softball fields. If you get to Delk Rd. /Lockheed, you've gone too far.

# **Exhibitors Note:**

Judges are not required to wait for dogs. Judges will break at their discretion.

Transfers will be accepted per AKC regulations. Completed transfer form must be submitted to the Trial Secretary no later than 30 minutes prior to the start of judging.

Some Obedience classes begin with a briefing. The briefing is combined for Beginner Novice A & B, if there are fewer than 20 total entries in the combined classes.

Saturday runs in forward order (low to high), Sunday runs in reverse order (high to low).
