Notes to Exhibitors

The AKC will collect a \$3.50 Event Service Fee for each entry of a dog in all AKC licensed rally trials. If a dog is entered in more than one class in the show, the event fees will be collected on each entry.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Georgia law (Rabies Control Law-O.C.G.A. -31- 19) requires that dogs be vaccinated against rabies so be sure to have proof of rabies vaccination available.

Refunds will be given for bitches that come in season after entries close less a \$10.00 administrative fee. Bitches in season are not permitted at the show site.

No refund for errors on entry forms or if a dog is absent, disqualified, or excused. if the trial cannot open or be completed because of riots, civil disturbances, fire, extreme and/or dangerous weather, act of God, public emergency, act of public enemy, or any other cause beyond the control of the club or the Event Secretary.

Confirmations / Judging Program will be sent via email unless otherwise indicated.

Entries submitted by phone, fax, or e-mail will not be accepted. Owners are responsible for accuracy of information on the entry forms. After the closing date, no entry fees will be returned in the event of errors or cancellation of entries. Entries will not be accepted without fees or signature. An entry will not be accepted that is not on an official AKC entry form that includes the agreement. Returned checks do not constitute a valid entry fee. The Event Secretary will add a \$50 collection fee to the amount of each returned check.

Changes, additions, or corrections to entry forms must be submitted in writing or via email and received by the TRIAL SECRETARY BEFORE 6:00 pm, January 31, 2024.

The show site will be available to exhibitors starting at 7:00am on Saturday, December 14, 2024. Park in designated areas only. All dogs must be on lead both inside and outside the building except when in the ring. At both the show site and the motels, please pick up after yourselves and your dogs. Any complaints from motels regarding exhibitors may result in a Trial Committee hearing.

Transfers will be accepted per AKC regulations if the class is not full.

Completed and signed move-up form must be submitted to the Trial Secretary no later than 30 minutes prior to the start of judging.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Colles (rough, smooth), Buil Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenhelm and Prince Charles), Poodles (by, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been malled to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Raily trials should mark Breed as "All-American Dog/Mixed Breed." Size and Dam information shall remain blank for mixed breed entrants.

AKC Code of Sportsmanship

PREFACL: The sport of purebred dog competitive events dates prior to 1884, the year of ARC's birth. Sharedvalues of those involved in the sport include principles of sportsman ship. They are practiced in all sectors of our sport; conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the lundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purelyed dogs.
- Sportsmen commit themselves to values of fair play, honesty, countersy, and vigorous
 competition, as well as winning and losing with grace
- Sportsmen refuse to compromise their consultances and obligation to the sport of purebred
 dogs by injusting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the nerits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebrod dogs.
- Sportsmen find that vigorous competition and capital are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsman will deal fairly with all those who trade with them.
- Sportsman are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen sport any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Spiritsmen refuse to embarrass the sport; the American Kennel Club, or themselves while taking part in the sport.
