From I-385 North:

I-385 North to Exit 27 (Fairview Road). At the end of the ramp, at stop light, continue straight onto South Street.

Pass McDonalds (the road forks, continue straight). Go about one mile to turn left onto W. Curtis Street.

The Simpsonville Activity & Senior Center will be directly on your right.

From Greenville / Atlanta / Charlotte and I-385 South:

Take I-85 to I-385 South to Exit 31 (Highway 417). Turn left onto Highway 417 toward Simpsonville.

Go about 2.5 miles, turn right onto W. Curtis Street (by brick clock tower), cross RR tracks.

The Simpsonville Activity & Senior Center will be about 1/4 mile on your right.

Alternate directions from I-385 North or South:

Take I-85 to I-385 to Exit 29 (W. Georgia Road), then head east. Turn right onto N. Industrial Drive,

then left onto W. Curtis Street. The Simpsonville Activity & Senior Center will be about 1/2 mile on your left.
