

Blue Ridge Dog Training Club, Inc

Thank you for entering the obedience and rally trials the Blue Ridge Dog Training Club is holding in our training facility in the rear of The Sportsplex located at 221 Commonwealth Court, Winchester, VA 22602. Take Interstate 81 to exit 310. Follow 37 for 1/10 mile to the Route 11 north exit ramp. Turn left at the bottom of the ramp, then an immediate right at the light onto Commonwealth Court. The Sportsplex is at the very end next to One Life Fitness.

There will be limited parking along the back wall of the building by the entrance door for the training center. A fire lane is clearly marked and your vehicle must be parked front end perpendicular to the wall. If all available spaces in the back are taken, you may stop to unload your car then park in the regular parking lots around the building. Please do not park in the fire lane.

When walking your dogs, please do not cross the marked area line. The automotive company in the back owns the large grassy area opposite our entry door and we do not have permission to use this area. You can walk anywhere around the building, One Life Fitness and Honeybee Car. Please clean up after your dog. There will be several deposit sites around the area.

Since the flooring of our training center is field turf it is mandatory to put down a tarp or other waterproof floor covering underneath your crate, chair and any other items you may bring. Though we feel there will be plenty of room for crating, please be considerate of others and their need for a place to crate.

We will NOT have any food for sale during the trials. We are only supplying food for our judges. There are fast food and other restaurants in close proximity. Please plan to bring your own lunch and or beverages.

We will be offering new title ribbons for those earning obedience or rally titles at these trials.

Finally, please double check your entry confirmation to make sure you are entered in the correct class for the correct day. If there is a discrepancy please notify the trial secretary ASAP. We will open at 8:00 AM each day for classes to begin at 9:00 AM.

Important Information Related To Covid

- Exhibitors are expected to follow state, local government, event and facility guidelines.
- Limited crating will be available indoors
- Because of limited crating, NO UNENTERED DOGS will be allowed
- No Spectators, please
- Masks – Masks will be required for unvaccinated when in the building
- Course maps for rally classes
 - Only a few paper course maps will be available
 - Course maps will be posted at the site in several locations
- Briefings and walk-throughs may be divided into smaller groups
- Ribbons may be self-serve
- When done for the day, exhibitors should leave the building in order to minimize congregating.
