ROUTES TO THE SHOW

From Center City Philadelphia:

Take I-76 West to Exit 343 for PA-611 North toward Doylestown and continue about 3/4 mile. Make a sharp right onto Mill Road. Take the first right onto PA-263 South/York Road and proceed 1/4 mile. Turn left onto Terwood Road. After 1/2 mile, make a right onto Davisville Road. Watch for a "Tires Plus" sign on the right. Approximately 100 yards further along on the LEFT, you will see the sign and driveway for Premier Office Solutions. Turn left into the drive, go past the side of the building and turn left behind it. Drive down the very long parking area, parallel to the building. Y2K9s is at the opposite end, and so is our entryway.

From PA Turnpike:

Take Exit 343 for PA-611 South toward Willow Grove. Continue on 611 (Easton Road) to Davisville Road (road immediately next to train tracks), turn left. You will see a sign and driveway for Premier Office Solutions. Turn right into the drive, go past the side of the building and turn left behind the building. Drive through the parking lots, parallel to the building. Y2K9s is at the opposite end as is the entrance.

From Northern Suburbs:

Take PA-611 South. In Horsham, turn left onto Horsham Road and proceed about 1 mile. Turn right onto PA-263 South/York Road and proceed 3/4 mile. Turn left onto Terwood Road. After 1/2 mile, make a right onto Davisville Road. Watch for a "Tires Plus" sign on the right. Approximately 100 yards further along on the LEFT, you will see the sign and driveway for Premier Office Solutions. Turn left into the drive, go past the side of the building and turn left behind it. Drive down the very long parking area, parallel to the building. Y2K9s is at the opposite end, and so is our entryway.

From Western Suburbs:

Take I-476 North (Blue Route) to the PA Turnpike/I-276 East. Follow directions from Exit 343 as above.

From NJ:

From Hunterdon County area, take US-202 South to PA-611 South and follow directions above. From Mercer or Burlington Counties, take the PA Turnpike West and follow directions above.

TRIAL INFORMATION AND REGULATIONS

Trial competition will use three judging rings. A practice ring is available for all entrants.

Entries can be made online or by mail. **Enter online** with no surcharge at <https://showentries.info/>. Entry fees must be paid with online entry submission. **Mail-in entry** forms are available at <https://showentries.info/> for download. If a check is returned, PDTC will add any bank fees to the amount due. Entries are acknowledged via email as soon as they are received and processed. Please be sure to add [ShowEntriesInfo.com](https://showentries.info/) to your email allowed list.

PLEASE VERIFY THE ACCURACY OF YOUR ENTRY INFORMATION as soon as you receive the processing email and respond immediately if any changes are noted. Changes or corrections to entry forms must be received via email prior to the close of entries.

Armband numbers are confirmed and judging programs are distributed via email for all entries shortly after closing, when final judging assignments are complete.

Refunds will be given for entries withdrawn in writing or via email before the closing date and time. PDTC will refund all but a \$10 administrative fee of the entry fee for bitches that come into season after the closing date of the trial, and for no other reason. The Trial Secretary must be notified of such claim for refund either hand-delivered no later than 30 minutes prior to the start of the first class in the trial or via email prior to the trial.

No refunds for errors on entry forms, or if a dog is absent, disqualified, or excused by a veterinarian or Judge, or barred from competition by action of the Show Committee.

No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club. If cancellation is decided before the event, notification will be posted on: philadelphiadogtraining.org

Transfers will be accepted per AKC regulations if you have earned a new title after closing, and if the class is not full. The fee difference will apply for transfers from a non-regular to a regular class. Completed and signed transfer form must be submitted to the Trial Secretary no later than 30 minutes prior to the start of judging for the trial. Click [AKC Obedience Trial Transfer Form](#) to download a copy of the form. Due to Judging Limits, we cannot guarantee that all requested Transfers can be accommodated.

DOGS MAY ARRIVE any time prior to their scheduled time of judging.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the ring when their class is called to be judged. All dogs must be held on leash or confined to crates, except when being judged or in designated warm-up areas. No Flexi leashes permitted in the building. No ex-pens in the building.

HEALTH: Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

DECLINATION OF ENTRIES/REMOVAL OF DOG: The show committee may refuse to admit or may remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against the show-giving club or any official thereof.

PHILADELPHIA DOG TRAINING CLUB, INC.(PDTC) assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property or vehicle and further assumes no responsibility for children. Exhibitors shall hold the Show Committee harmless and indemnify it against any legal proceeding arising from any accident.

Jump Heights will be in ASCENDING (small to tall beginning with the lowest jump) order for all classes
