Additional information:

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations including rabies. By entering this trial, you are verifying that your dog possesses a current Rabies vaccination on the day of the trial.

ALL CLASSES – All dogs will be judged from **low to high** jump height. Ring size is 40' x 50'.

Judging will be in the Main building, and crating will be in the Annex.

Handlers are expected to have their dog ready at the ring on time. There will be closed-circuit television in the Annex along with check-in charts that should provide adequate information on the armband number of the team being judged. The judge is not required to wait for any team holding up a class. Warm up areas are clearly marked.

Junior Handlers please bring your number with you and report to the Trial Secretary in the main office before your dog is scheduled to run. The check-in steward in the annex crating area will provide directions.

By submitting an entry to this Event and/or by attending this Event, all exhibitors and attendees agree on behalf of themselves, their agents, their guests, and their minor children that (a) it is their responsibility to comply with Pandemic guidelines set forth by RDOC, national, state, county or local authorities, and (b) they are personally responsible for their safety and actions during the Event, and (c) to comply with all RDOC policies and rules, including but not limited to any guidelines, signage, and/or instructions. Exhibitors and attendees for themselves, and on behalf of their guests, agents, and minor children release, waive, and discharge RDOC, its board members, directors, agents, contractors, affiliates, and volunteers from all liability related to Covid 19.

This is a non-smoking building.

There will be a handicap accessible Port-a-john for exhibitors outside the annex. There are bathrooms in the annex and main building.

Exhibitors may unload their cars to crate in the Annex beginning at 7 a.m. June 22-23, 2024. After unloading your cars, your vehicles should be moved across Tomlynn Street to the area marked EVENT PARKING.

Please **clean up after your dogs** – The dog potty area is the gravel lot across from the Annex. There is a small grassy area beside the potty area that is also available for use. There are bags for you to clean up, and a trash can for disposal. **Please do not dispose of your dogs' waste in the Port-a-johns.**

Please DO NOT potty your dog in the mulched beds along Tomlynn Street, and **do not** allow your male dog to relieve himself on the walls or doors of the buildings.

No Flexi-Leads are permitted.

Unentered dogs will not be allowed in the main building.

No dog whistles are permitted.

On-line entries are encouraged at ShowEntries.Info Entries without fees paid in full will not be accepted. Acknowledgement of entries will be made as soon as practical. Should such acknowledgement not be received by the exhibitor within a reasonable time, please notify the Trial Secretary.

No entry shall be accepted which specifies any conditions as to its acceptance.

Entry fees shall not be refunded if a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Trial Committee.

No entry fee will be refunded in the event of errors or cancellation of entries after the published closing date.

The well-being of volunteers, judges, participants, and dogs is of paramount importance. Extreme weather conditions such as but not limited to snowstorms, hurricanes, lightning, extreme heat/cold must be considered for the safety of everyone involved. In the event the trial is canceled due to extreme weather or halted due to extreme weather no refund of entry fee will be made.

Dogs may arrive approximately one hour prior to the start of the trial. Dogs not required for further judging are excused. All dogs must be held on leash or confined to their crates except when being judged.
