Directions to Trial Site

Coming into Savannah from I-16 East, take the 37th Street Exit. It will route you into eastbound traffic. Stay on 37th Street until you come to Abercorn Street.

Go right at the intersection. Stay on Abercorn for several miles until you come to Stephenson Avenue. Take a left at the intersection. Critz Dealership is on the left side of Abercorn but will be on your right as you turn.

Go to the end of Stephenson Avenue and at the light, take a left onto Waters Avenue.

Take the next right onto Cornell Street which becomes Seawright at the curve.

Benedictine will be on your left.

If you're coming from South of Savannah on 95, take the Abercorn exit from 95 north and follow the directions as above.

Take a right onto Stephenson Avenue at the Critz Dealership and follow the same as above.

Trial Entry Information and Trial Regulations

Entries are acknowledged via email as soon as they are received and processed. Please review and respond right away if any changes are noted. Armband numbers are confirmed and judging programs are distributed via email for all entries. This will be shortly after closing, when final judging assignments are complete, and exhibitor armband numbers have been assigned. Premium lists for future trials will also be sent out via email.

Refunds will be given for entries withdrawn in writing or via email before the closing date and time. SDTC will give a refund less \$5.00 for bitches that come into season after the closing date of the trial, and for no other reason. You must submit a signed statement of the dog's condition from your veterinarian on his/her office stationery along with your request for such a refund to the trial secretary at least 30 minutes before the start of the trial.

No refunds for errors on entry forms, or if a dog is absent, disqualified, or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.

Returned checks, or credit card payments which are subsequently disputed, ARE NOT valid payment of entry fees. An additional \$25 fee plus bank charges will be added, and the exhibitor will be expected to make payment in full.

Changes or corrections to entry forms must be received in writing or via email prior to the close of entries. Indicate '**UDX**', '**PUDX**', '**RAE**', or '**RACH**' if you are entering the corresponding classes and want no entry if any of the classes is already closed due to entry limitations (Obedience Regulations: Chapter 1 Section 27).

Obedience High Jump Height is required for all entries in classes with jumps. **Rally Jump Height** is required for Advanced, Excellent and Master classes.

Entry Fees must be paid with entry submission for online entries. If a check is returned, we will add any bank fees to the amount due.

Transfers will be accepted per AKC regulations if the class is not full. The fee difference will apply for transfers from a non-regular to a regular class. Completed and signed transfer form must be submitted to the Trial Secretary no later than **30 minutes** prior to the start of judging for the trial.

Show Site will be open at 3:00 to 8:00 pm Friday. Show hours are 7:00 am - 4:00 pm Saturday & Sunday. No overnight parking; no dogs may be left in the building overnight.

All dogs present must be held on leash or confined to crates, except when being judged or in designated warm-up areas. No Flexi leashes or prong collars permitted in the buildings. No ex-pens permitted in the buildings. Exhibitors and handlers will be responsible for clean conditions in and around their dog's crate.

SDTC and Benedictine Military School assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. For safety reasons, no strollers are permitted in the building during show hours.

Savannah Dog Training Club, Inc. reserves the right to remove any animal in distress from a parked vehicle or crate, and all persons attending this dog show shall hereby waive any claim for damages against the club for such removal.
