Telephone: (757) 234-0461. Directions: From MDTC, take I-664 North to I-64 West to Exit 256B (Victory Boulevard). Continue 1.5 miles to US17 South. Turn right. Continue .5 miles to clinic.

Nearest Urgent Care (Humans) – Sentara Complex Hospital Trauma Center, 3000 Coliseum Drive, Hampton, VA (approx. 5 miles from trial site). Directions: Turn left onto Newsome Rd when leaving MDTC. Turn Right onto Salters Creek. Turn right onto W Queen St. Turn left onto W. Pembroke Avenue. Use left two lanes to turn left onto LaSalle. Left onto N Armistead, go 3.5 miles and turn left at Vernon Stuart Dr. After .3 miles Sentara CarePlex will be on your right.

Directions to Trial Site

From Monitor-Merrimac Tunnel on I-664 - take Powhatan Parkway/Power Plant exit. Go right at end of exit and take the first left onto Salters Creek Road. Go approximately .6 miles and turn right on Newsome Place. Merrimac Dog Training, 15 Newsome Place, will be on the right

NOTE: Newsome Road cannot be accessed from North Pembroke Road. You will need to access Newsome Road from Salters Creek Road. Your GPS may not show this; the road is there but it is blocked with concrete blocks.

Trial site - doors will open at 8 AM Saturday and 7 AM Sunday.
