NEW TITLE AWARDS

Any dog completing a rally title at this trial will receive a new title ribbon offered by Charlotte Dog Training Club.

Any dog completing an RAE title at this trial will receive a large rosette offered by Charlotte Dog Training Club.

Any dog completing a RACH title at this trial will receive a large rosette offered by Charlotte Dog Training Club and a RACH decorated cone created and donated by Kelsey Mayo.

Ribbons will be awarded to teams earning a perfect score of 100, a Double Q in Rally Excellent and Advanced, and a Triple Q in Rally Master, Excellent, and Advanced.

Trophies may be substituted at the discretion of the Charlotte Dog Training Club. All awards must be picked up before the trial ends.

No awards will be mailed.

NOTICE TO EXHIBITORS

The American Kennel Club (AKC) Rules and Regulations will govern this Trial and Exhibitors must make themselves familiar with the agreement of the AKC referred to on the reverse side of the entry form in this Premium List

ENTRIES

No Entry will be accepted which specifies any condition as to its acceptance. Signature required, unsigned entries, and entries received without payment will not be accepted. **Note: Entry Forms without the full AKC Agreement and Rules and signature on the reverse side will not be accepted.**

RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The club will add a \$25.00 collection fee to the amount of each returned check.

Entries will be acknowledged via email as they are received and processed. PLEASE VERIFY THE ACCURACY OF YOUR ENTRY INFORMATION as soon as you receive the processing email.

Confirmation and armband number will be sent via email after entries close. Those without an email address will be mailed by USPS to the address on the entry form. Please be sure to add **ShowEntries.Info** to your email allowed list.

REFUNDS

Refunds (less the administrative processing fee) will be made for bitches in season if a veterinarian's certificate is presented to the Trial Secretary at least 30 minutes prior to the start of the trial.

Entry fees shall NOT be refunded in the event a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly.

If, because of riots, civil disturbances or other acts beyond the control of the club it is impossible to open, or to complete the Show NO REFUND will be made.

LOSS OR DAMAGE

The Trial Committee and the trial secretary will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Trials.

SHOW SITE

TRIAL HOURS are from 8:00 A.M. to 6:00 P.M. The building will be opened at 7:00 A.M.

No smoking allowed in the show building.

No firearms allowed in the show building or show grounds.

Limited indoor crating will be allowed for entered dogs. Each crate and chair must be placed on a water-proof mat or pad. Due to space constraints, no pop-up dog tents are permitted in the building.

There is no overnight parking. The building and gate to the property will be locked after the trial ends each day.

DOGS

Only dogs entered in the trial are permitted in the building. All dogs present must be held on leash or confined to their crates except when being judged. Dogs must be ready for judging. Exhibitors alone are responsible for the presence of their dogs in the ring. Judges are not required to wait for any dog holding up a class.

Dogs are not allowed in the building overnight.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

DIRECTIONS TO THE TRIAL SITE

From Greenville, SC:

Take I-85 North to South I-485 (exit 30) towards Pineville.

Take I-77/21 South (exit 67) towards Columbia.

Note: on I-485 the exit numbers will decline to 0 then start at 67 at the I-77 exit.

On I-77 South, take exit Take exit 79 to merge onto SC-122 W/Dave Lyle Blvd

Merge onto SC-122 W/Dave Lyle Blvd

Turn right onto State Rte 195/Mt Gallant Rd

Turn right onto Burkette Rd. Follow Burkette Road to the end. Drive through the gates and follow the road to the right to the CDTC building.

From Charlotte/Virginia/Raleigh:

Take I-85 South to I-77 South to Exit 81 Palmetto Parkway

Turn right at the light at the top of the exit ramp. In .6 miles at the stop sign, make a left onto Mt. Gallant Road. In .4 miles make a left onto Burkett Drive (first left after the RR tracks).

Follow Burkette Road to the end. Drive through the gates and follow the road to the right to the CDTC building.

From Columbia SC:

Take I-77 North to Exit 79 SC-122 W.Dave Lyle Blvd

Turn right onto State Rte 195/Mt Gallant Rd

Turn right onto Burkette Rd. Follow Burkette Road to the end. Drive through the gates and follow the road to the right to the CDTC building.
