Jump Height is required for all obedience and rally classes with jumps.
Classes with jumps will run in **ascending** jump height order,
beginning with the lowest jump. Exceptions to jump height running order may
be made for handlers with multiple entries.

Judges are not required to wait for dogs. It is the responsibility of the owner or
handler to have the dog at ringside when its class is called.

Transfers will not be allowed after closing,
except in the case of ineligibility as per AKC rules and regulations.

Refund in full for bitches in season with veterinarian's note.
If you have any questions or to request an in-season refund, contact the
onsite MHKA Trial Secretary, Polly deMille

No entry fee will be refunded if the trial cannot open or be completed by reason of riots,
civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any
other cause beyond the control of the organizing committee. No entry fee will be
refunded in the event a dog is absent, disqualified, excused, or barred from competition
by the action of the Event Committee.

All dogs present must be on leash or confined to a crate except when being
judged in the ring.

Crating space will be available on a limited basis, first come.
Catalogs will not be available for purchase.

A new title medal will be available to all dog and handler teams finishing an
obedience or rally title.

Directions to the trial site:

From the South (NYC and New Jersey): I-87 North (NYS Thruway) to
Saugerties Exit 20, then right onto Route 212 East, then right onto Kings
Highway for 3 miles, then right onto Industrial Drive. Dream Dogs Training
Center is on the left. Cars keep to the right when entering.

From the North (Albany and Western Massachusetts): I-87 South (NYS
Thruway) to Saugerties Exit 20. Turn left onto Route 32 South, then turn left
onto Route 212 East, then turn right onto Kings Highway. Follow for 3 miles,
then turn right onto Industrial drive and follow to the end. Dream Dogs Training
Center is on the left. Cars keep to the right when entering.

From the East: Take the Kingston Rhinecliff Bridge/Route 199 then exit onto
Route 9W North for 4.5 miles then turn left onto Glasco Turnpike and follow
over the RR tracks then turn right onto Kings Highway. Then prepare to quickly
turn left onto Industrial Drive, follow to the end of the road. Dream Dogs
Training Center is on the left. Cars keep to the right when entering
