DIRECTIONS TO THE EVENT SITE

From Greenville, SC:

Take I-85 North to South I-485 (exit 30) towards Pineville.

Take I-77/21 South (exit 67) towards Columbia.

Note: on I-485 the exit numbers will decline to 0 then start at 67 at the I-77 exit.

On I-77 South, take exit Take exit 79 to merge onto SC-122 W/Dave Lyle Blvd

Merge onto SC-122 W/Dave Lyle Blvd

Turn right onto State Rte 195/Mt Gallant Rd

Turn right onto Burkette Rd. Follow Burkette Road to the end. Drive through the gates and follow the road to the right to the CDTC building.

From Virginia/Raleigh:

Take I-85 South to I-77 South to Exit 79 SC-122 W/Dave Lyle Blvd

Then follow the Greenville directions

From Columbia SC:

Take I-77 North to Exit 79 SC-122 W.Dave Lyle Blvd

Turn left onto Dave Lyle Blvd and follow the Greenville directions

Exhibitors Note:

Judges are not required to wait for dogs. Judges will break at their discretion.

Transfers will be accepted per AKC regulations. Completed transfer form must be submitted to the Trial Secretary no later than 30 minutes prior to the start of judging.

Some Obedience classes begin with a briefing. The briefing is combined for Beginner Novice A & B, if there are fewer than 20 total entries in the two classes.

Saturday runs in forward order (low to high). Sunday runs in reverse order (high to low).
