**From Rt 80 East or West (exit 27A) to Rt 206 South:**

Go 4 miles, turn right onto Bartley Rd, just before the railroad overpass. Go about a mile to Top Dog on the right.

**From Rt 287 (exit 22B) to Rt 206 North:**

Take 206 through the town of Chester and cross the intersection of 206 and 24 / 513. Stay on 206 to the second traffic light and make a left onto Bartley-Chester Rd. Cross over the railroad tracks. Turn right and then make an immediate left to Top Dog.
