Directions to the trial site

From Spartanburg/Greenville via I-385S to I-1-26E

Take Exit 209(Ashley Phosphate Road). Use the right 2 lanes to turn right onto Ashley Phosphate Rd/State Rd S-10-75. Go 0.7 miles. Turn right onto Southrail Road. Go 0.7 miles. Turn right into group of buildings. Training facility is the 2nd building on the right (300A).

From Charlotte via I-77S

Take I-77to I-26 E. Take Exit 209(Ashley Phosphate Road). Use the right 2 lanes to turn right onto Ashley Phosphate Rd/State Rd S-10-75. Go 0.7 miles. Turn right onto Southrail Road. Go 0.7 miles. Turn right into group of buildings. Training facility is the 2nd building on the right (300A).

From Augusta via I-20E

Stay on I-20E, merge onto I-26E at Exit 64A toward Charleston.

Take Exit 209(Ashley Phosphate Road). Use the right 2 lanes to turn right onto Ashley Phosphate Rd/State Rd S-10-75. Go 0.7 miles. Turn right onto Southrail Road. Go 0.7 miles. Turn right into group of buildings. Training facility is the 2nd building on the right (300A).

From Savannah

Take I-95 to US-17 North towards Charleston. Follow signs for I-526 East towards North Charleston. Use right lane to take exit 17 for I-26 W towards Columbia. Use right lane to take exit 209A/209B for Ashley Phosphate Rd. Take a left onto Ashley Phosphate Rd. Turn right onto Southrail Road, go 0.7 miles turn right into group of buildings. Training facility is the 2nd building on the right (300A).
