**Entry Limitations and Regulations**

Exhibitors please note: There is a good chance that the open and utility judge  
will fill based on regular class entries; therefore, we have established the  
following policy for handling and prioritizing entries:

- Combined entries for all classes are limited to 8 hours per judge each day.
- Regular class entries have first priority and will be accepted up to the limits for the assigned judge. Any additional entries will be waitlisted.
- Obedience optional titling & preferred class entries have second priority; non-regular class entries have third priority; all these entries will be waitlisted.
- After closing, waitlisted entries will be accepted by priority, in the order received, up to the limits for the assigned judge.

Transfers will be accepted at the trial per AKC regulations.

All classes will be run in **forward catalog order on Saturday** (ascending jump height, beginning with the lowest jump height entered for classes with jumps); and in **reverse catalog order on Sunday** (descending jump height beginning with the highest jump height entered for classes with jumps). Exceptions may be made in obedience for handlers with multiple entries.

**\$5 of each entry fee is a non-refundable administrative charge**

**Obedience Regular, Optional Titling & Preferred Classes**

**\$33.00** for the first entry of a dog in these classes each day

**\$29.00** for each additional entry of the same dog in these classes each day

**Rally Classes: \$33.00** for the first entry of a dog in rally each trial each day

**\$29.00** for each additional entry of the same dog in rally each trial each day

**Non-Regular Obedience Classes - \$29.00** per entry in Wild Card Classes

**\$8 for 5 minutes; one Rally Choice ring will be available.**

DOCG is pleased to offer an OC Match with ring time for “run-thrus”.  
Handlers may use the ring for exercises as they wish. Entries are limited to 2 hours of match time, 15 entries per ring. Second runs available, if time permits.

Club member worker match runs will take place before the match begins.

**There are no prizes**, ribbons, scoring or placements for the Match.

**Verbal corrections** and gentle guidance will be permitted.

**No food or toys** will be permitted in the rings.

**Group sits and downs** are included at no additional charge for dogs signed up for the Novice ring. Group exercises will be conducted at appropriate intervals at the club's discretion.

**\*\*PLEASE NOTE\*\*** There is not an option for Rally Choice so sign up for a Rally Novice Slot and this will reserve your spot.

DOCG club members will help with the match and **match workers** will have ring time separately before the match begins.

## Trial Entry Information and Trial Regulations

**Entries** are acknowledged via email as soon as they are received and processed. Please review and respond right away if any changes are noted. Armband numbers are confirmed and judging programs are distributed via email for all entries. This will be shortly after closing, when final judging assignments are complete, and exhibitor armband numbers have been assigned. Premium lists for future trials will also be sent out via email.

**Refunds** will be given for entries withdrawn in writing or via email before the closing date and time. DOCG will give full refunds per AKC regulations for bitches that come into season after the closing date of the trial, and for no other reason. You must submit a signed statement of the dog's condition from your veterinarian on his/her office stationery along with your request for such a refund to the trial secretary at least 30 minutes before the start of the trial.

**No refunds** for errors on entry forms, or if a dog is absent, disqualified, or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.

**Changes** or corrections to entry forms must be received in writing or via email prior to the close of entries. Indicate **UDX (OB/UB)**, **PUDX (PO/PU)**, **RAE (AB/EB)**, **RACH (AB/EB/Master)** if you want no entry if one class is already closed due to entry limitations.

**Obedience High Jump Height is required for all entries** in classes with jumps. **Rally Jump Height** is required for Masters, Advanced and Excellent classes.

**Entry Fees** must be paid with entry submission for online entries. If a check is returned, we will add any bank fees to the amount due.

**Transfers** will be accepted per AKC regulations if you have earned a new title after closing, and if the class is not full. The fee difference will apply for transfers from a non-regular to a regular class. Completed and signed transfer form must be submitted to the Trial Secretary no later than **30 minutes** prior to the start of judging for the trial.

**Show Site** will be open from 5:00 pm -8:00 pm Friday. Show hours are 7:00 am - 5:00 pm Saturday & Sunday. No overnight parking in the activity center parking lot except with Club permission; no dogs may be left in the building overnight.

**All dogs** must be held on leash or confined to crates, except when being judged or in designated warm-up areas. No Flexi leashes or prong collars permitted in the buildings. No ex-pens in the buildings. All crates must be securely closed, including the tops

**No camping** permitted at the show site.



## Directions to the Show Site

### From I-385 North:

- I-385 North to exit 27 (Fairview Road). At the end of the ramp, at stop light, continue straight onto South Street.
- Pass McDonalds (the road forks, continue straight). Go about one mile, then turn left onto W. Curtis Street.
- The Simpsonville Activity & Senior Center will be directly on your right.

### From Greenville / Atlanta / Charlotte (going through Simpsonville):

- Take I-85 to I-385 South to exit 31 (Highway 417). Turn left onto Highway 417 toward Simpsonville.
- Go about 2.5 miles, turn right onto W. Curtis Street (by brick clock tower), cross RR tracks.
- The Simpsonville Activity & Senior Center will be 1/4 mile on your right.

### Alternate Route from I-385 from either direction:

- Take I-385 to exit 29 (Georgia Rd, Highway 541, heading East).
  - From I-385 heading South, turn left and cross over I-385
  - From I-385 heading North, turn right.
- Take the first right onto N Industrial Drive (just past the interstate exit)
- Take the first left onto W. Curtis Street (about 3/10 mile).
- The Simpsonville Activity & Senior Center will be 1/2 mile on your left.

**Motor home parking** is available on the street adjacent to the show site.

No motor home or trailer parking in the Simpsonville Activity Center parking lot.
