\$31 for the first entry of each dog, each day, each trial

\$29 for each additional entry of the same dog in each trial

Fees include all AKC event service and recording fees.

\$5 of each entry fee is a non-refundable administrative charge.

Refund for bitches in season (less administrative fee) with veterinarian's note.

Jump Height is required for all obedience and rally classes with jumps.

Classes will run in forward catalog order (low to high jump height).

Exceptions may be made for handlers with multiple entries.

**Early crating/setup will be allowed on Friday, March 27, 2026, beginning at 5:00 PM; not before as this is a daycare facility.**

Also, on Friday, there will be at least one ring available to rent for practice purposes between 5 PM – 7 PM at a cost of \$10/10 minutes, cash only.

Pay when you sign up, not in advance; and **no treats in the ring please.**

**Transfers will be allowed after closing,**  
as per AKC rules and regulations.

All dogs present must be on leash or confined to a crate expect when being judged in the ring.

Crating space is limited. Exercise pens will not be allowed. No dogs may be left in the building overnight. The trial site requires that a tarp be placed on the floor underneath your crates.

Crates may be left overnight, but must be removed 30 minutes after the end of the event on Sunday.

Exhibitors are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and or/children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

No awards/ribbons will be mailed.

Exhibitors are responsible for cleaning up after their own dogs. Please help us keep this site clean for future use.

Un-entered dogs and litters of puppies are not permitted on trial grounds.

Owners are responsible for being ready at the ring gate. Judges are not required to wait on dogs or handlers.

## NQ Drawing

## DRIVING DIRECTIONS TO THE TRIAL SITE

Ultimutt Knoxville

11225 Threadstone Lane, Knoxville, TN 37932

**From EAST:** Take I-40 West through Knoxville. Take Exit 374 (Lovell Road) Turn RIGHT onto Lovell Road. In about .5 miles, turn LEFT onto Gilbert Drive. Then take first LEFT onto Dalen Lane.

Take second or third RIGHT. Trial Site will be straight ahead. **From WEST** Take I-40 East toward Knoxville. Take Exit 374 (Lovell Road) Turn LEFT onto Lovell Road. In about .5 miles, turn LEFT onto Gilbert Drive. Then take first LEFT onto Dalen Lane.

Take second or third RIGHT. Trial Site will be straight ahead. **From SOUTH:** Take I-75 North toward Knoxville. Take the I-40 East exit (RIGHT fork). Take I-40 East to Exit 374 (Lovell Road) Turn LEFT onto Lovell Road. In about .5 miles, turn LEFT onto Gilbert Drive. Then take first LEFT onto Dalen Lane. Take second or third RIGHT. Trial Site will be straight ahead.

**From NORTH:** Take I-75 South toward Knoxville. Take I-640 West to I-40 West. Take I-40 West to Exit 374 (Lovell Road) Turn RIGHT onto Lovell Road. In about .5 miles, turn LEFT onto Gilbert Drive. Then take first LEFT onto Dalen Lane. Take second or third RIGHT. Trial Site will be straight ahead.

**From NORTHEAST:** Take I-81 South toward Knoxville. Merge onto I-40 West. Take I-40 West to Exit 374 (Lovell Road) Turn RIGHT onto Lovell Road. In about .5 miles, turn LEFT onto Gilbert Drive. Then take first LEFT onto Dalen Lane. Take second or third RIGHT. Trial Site will be straight ahead.
