From Rt. 78/22 – Exit 49A Rt 100 South to North Church Street and Turn Right

North Church St. becomes Crow Hill Road, follow to Belle Vista Lane and Turn Left

Transfers will be accepted per AKC regulations. Completed transfer form must be submitted to the Trial Secretary no later than 30 minutes prior to the start of judging.

All Rally classes begin with a walkthrough, which is combined for A & B classes when there are no more than 20 total entries.

Some Obedience classes begin with a briefing. There briefing is combined for Beginner Novice A & B.
