CRATING

4Paw is going to allow indoor crating but because of limited space and close proximity to the main room, we have to install the following guidelines:

- There is a nicely shaded parking pad to the right of the agility field and in the park for dogs who cannot crate indoors.
- VOLUNTEERS WILL GET GUARANTEED CRATE SPACE.
- The space may get tight, NO CRATE AGGRESSIVE DOGS. You will be asked to remove your dog.
- We will provide crates for large dogs on a first come, first served basis.
 - These are the only crates available for large dogs.
 - Please do not bring your own crates in.
 - You must agree to allow small dogs to stack on top of the crate.
 - NO saving crates.
- No chronic barkers, whiners, or crate diggers.
- Small dogs may use their own crates and stack on top of the large dog crates.
- There is limited crating in the middle “pass through” room for exceptionally well behaved dogs.
 - There are crates for both small and large dogs.
 - Dogs must be completely quiet to crate in this room as it's a pass-through to the main room.
 - If you wonder whether your dog meets the "exceptional" criteria, then it does not.
 - Dogs are subject to removal if they become obnoxious.
 - Dogs crated in the aisle crates may benefit from a sheet to block dogs coming and going.
- Absolutely NO crating in the main room.
- No hanging out with your dog in the main room.
- No early setup is allowed UNLESS YOU ARE A STEWARD.
- Please be respectful of other people and don't block crates or pathways.
- Again, it may get tight, so cooperation is needed.
- **To maximize building familiarity for exhibitors, teams permitted inside will be the team showing, the team on deck, and the team in the hole. Spectators are also permitted but must stay clear of the warm-up area.**

AIRING DOGS

The building is adjacent to the Cobb County Civic Center Sports facility, so there is plenty of green space to walk dogs. Please remember to pick up after your dogs.

PARKING

In addition to limited parking in front of the building, there is a parking pad in the Cobb Civic Center Park. This is extremely convenient to the building, within 50 feet. Take the second driveway on the right to park here.

On Saturday and Sunday, you may park in front of the businesses to the left of Alchemy. **DO NOT BLOCK THEIR GATES!** You may also park behind those who are parked at the Alchemy gates.

DO NOT BLOCK NON-ALCHEMY GATES

From the South:

I-75 North. Exit 261—GA-280 toward Lockheed/Dobbins AFB. After approximately 3.2 miles, turn right onto Fairground St. SE. Glover St. will be approximately .25 miles on your left. If you get to the Quick Trip, you've gone too far.

From the North:

I-75 South, Exit 263 – GA-120 toward Marietta. Go about a mile and turn left on Fairground St. NE. Glover St. will be approximately 1/4 mile on the right just pass the Marietta Civic Center & softball fields. If you get to Delk Rd. /Lockheed, you've gone too far.
