#### From the South:

I-75 North. Exit 261—GA-280 toward Lockheed/Dobbins AFB. After approximately 3.2 miles, turn right onto Fairground St. SE. Glover St. will be approximately .25 miles on your left. If you get to the QT, you've gone too far.

#### From the North:

I-75 South, Exit 265 – GA-120 toward Marietta/White Water. Go almost a mile and turn left on Fairground St. NE. Glover St. will be approximately 1.4 miles on the right just past the Marietta Civic Center & softball fields. If you get to Delk Rd./Lockheed, you've gone

too far.

## Trial Information and Entry Regulations

### Trial Hours

7:00am—6:00pm Eastern Daylight Savings Time

- Building will open at 7:00am all both days
- **NO x-pens allowed.**
- **NO retractable leads permitted indoors**
- **NO strollers: dog or human**
- **ENTRY LIMIT OF 60 PER TRIAL**

Indicate 'RAE' and/or "RACH" if you are entering both Advanced B and Excellent B or Advanced B, Excellent B, Master and you want no entry if one class or the other is already closed due to entry limitations (Rally Regulations: Chapter 1 Section 24).

**Refunds** will be given per AKC regulations and for entries withdrawn in writing or email before the closing date and time. 4Paw will refund

entry fees for bitches that come into season after the closing date of the trial less a \$5.00 administrative fee **per entry**.

**No refunds** for errors on entry forms, or if a dog is absent, disqualified, or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.

**Confirmations/Judging Program** will be sent via email unless otherwise indicated.

**Changes** or corrections to entry forms must be received in writing or email prior to the close of entries. Entries are acknowledged via email as received. Entries are confirmed and the judging program is distributed via email when all entries are processed, final judging assignments are complete, and exhibitor armband numbers have been assigned.

**Entry Fees** Make one payment for the combined total of all entries and pre-orders. Returned checks are not a valid payment of fees; the club will add a collection fee to any returned check.

**Transfers** will be accepted per AKC regulations if the class is not full. Completed and signed move-up form must be submitted to the Trial Secretary no later than **30 minutes** prior to the start of the trial.

**Show Site** will be open to exhibitors at 7:00 am Saturday & Sunday morning. No dogs may be left in the building overnight.

**Exhibitors** should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**CLEAN UP** Exhibitors will be responsible for picking up after their dogs and maintaining clean conditions in and around their crates.

# CRATE INFORMATION

---

Limited indoor crating is available for very well behaved dogs and **ONLY** for class dogs. Small dogs may use their own crates and will be stacked on the larger crates. The middle room, which serves as a pass-through to the ring, is reserved for extremely well behaved dogs. When your class is over, please crate your dog in your car to allow room for the next set of dogs. E.G. RACH dogs clear out for Intermediate & Novice dogs for all trials. Disruptive dogs will be asked to leave. Please be considerate and work together to allow the maximum amount of crating.

**Stewards can reserve and crate indoors for all classes.**

To maximize building familiarity for exhibitors, teams permitted inside will be the team showing, the team on deck, and the team in the hole, and one person to video runs as needed by the exhibitor. Spectators are also permitted but must stay clear of the warm-up area.
