From Columbia, SC

- Approaching Spartanburg on I-26W, take Exit 22 toward Spartanburg (SC-296/Reidville Rd)
- Merge Right onto John B White Sr Blvd, continue 1 Mile;
- Holy Communion Lutheran Church on Left

From Charlotte, NC

- Approaching Spartanburg on I-85S, take Exit 70 toward Columbia, SC, merge onto I-26E and continue 4.5 Miles to take Exit 22 toward Spartanburg (SC-296/Reidville Rd)
- Keep left at top of ramp toward Spartanburg and merge left onto John B White Sr Blvd
- Continue 1 Mile; Holy Communion Lutheran Church on Left

From Greenville, SC

- Approaching Spartanburg on I-85N, take Exit 66 toward Spartanburg West/Wellford
- Merge onto US-29N toward Spartanburg and continue 4.25 miles
- Merge onto I-26E toward Columbia and take Exit 22 toward Spartanburg SC-296/Reidville Rd)
- Keep left at top of ramp toward Spartanburg and merge left onto John B White Sr Blvd
- Continue 1 Mile; Holy Communion Lutheran Church on Left
