Directions to the trial site

Top Dog Training Facility, 24 Bartley Road, Flanders, NJ 07836

Parking: All vehicles must be parked nose in - not parallel with edges of parking area.

From Rt 80 East or West (exit 27A) to Rt 206 South:

Go 4 miles, turn right onto Bartley Rd, just before the railroad overpass. Go about a mile to Top Dog on the right.

From Rt 287 (exit 22B) to Rt 206 North:

Take 206 through the town of Chester and cross the intersection of 206 and 24 / 513. Stay on 206 to the third traffic light and make a left onto Bartley-Chester Rd. Cross over the railroad tracks. Top Dog entrance is immediately on the left (red building).

EXHIBITORS: There will be no exhibitor crating in the Top Dog training building, but crating will be allowed in the Top Dog Day Camp building next door. Crating opens at 7:30 AM on Sunday.

All crates should have a mat under them.

All vehicles must be parked "nose in" towards the building...not parallel with edges of the parking lot.

You will be able to watch the rings in the Top Dog Building. We will monitor the number of people and ask that you not congregate.

You will be able to warm up your dog in the Top Dog building prior to your run.
