Obedience & Rally: The building will be available for you to set up starting at 5:00PM on Thursday. The building will close at 8:00PM.

Crating: In order to make the show safe for everyone, dogs must be in crates that are completely closed and secured on all sides except when being judged or in designated warm-up areas. This includes no open top crates, kennels or pens. By entering this trial, you are agreeing to these terms. Failure to comply may result in you leaving the trial or having a Committee Disciplinary Hearing. No Flexi leashes or prong collars permitted in the buildings. No ex-pens in the buildings.

Simpsonville Activity & Senior Center, 310 West Curtis Street, Simpsonville, SC 29681

From I-385 North:

I-385 North to **Exit 27** (Fairview Road). At the end of the ramp, at stop light, continue straight onto South Street.
Pass McDonalds (the road forks, continue straight). Go about one mile to turn left onto W. Curtis Street.
The Simpsonville Activity & Senior Center will be directly on your right.

From Greenville / Atlanta / Charlotte and I-385 South:

Take I-85 to I-385 South to **Exit 31** (Highway 417). Turn left onto Highway 417 toward Simpsonville.
Go about 2.5 miles, turn right onto W. Curtis Street (by brick clock tower), cross RR tracks.
The Simpsonville Activity & Senior Center will be about 1/4 mile on your right.

Alternate directions from I-385 North or South:

Take I-85 to I-385 to **Exit 29** (W. Georgia Road), then head east. Turn right onto N. Industrial Drive,
then left onto W. Curtis Street. The Simpsonville Activity & Senior Center will be about 1/2 mile on your left.

Some obedience classes begin with a briefing as listed. All rally classes begin with a walkthrough, which is combined only if there are not more than 20 total entries in the A & B classes.

Running order is forward catalog order / low to high in all classes on Friday & Saturday, and reverse catalog order / high to low on Sunday. Judges are not required to wait for dogs.

Judges will break at their discretion.
