Entries limited to 8 hours per judge per day. Entries in all classes will close when the limit is reached even if this occurs before the official closing date. A **wait list** will be maintained for each trial.

WDNY Facility Policies

All handlers will be required to bring indoor shoes to be worn while on the turf. They will no longer allow outdoor shoes on the turf. Dirt, mud and snow is damaging the turf.

Matting/blankets will be necessary under crates and chairs

No Dirt on Shoes and Personal Equipment

No Crumbly Dog Treats, Any Soft Treats are acceptable

No Glass on Training Floor

No Smoking anywhere on the property

All exhibitors must have their dogs under control at all times.

Anyone violating these policies will be asked to leave and will forfeit their entries for the weekend

BITCHES IN SEASON shall not be eligible to participate in the obedience trials. After the trials have closed, there will be a refund of entry fees. Written verification from a veterinarian must accompany the refund request. A copy of the dog's final confirmation must be sent with the verification from the veterinarian. Requests must be received by the trial secretary no later than 5 days following the trial. The

documents may be sent by U.S. mail or scanned and sent by email to the [Trial Secretary](#).

TRANSFERS are permitted as provided for in Chapter 1, Section 16a of the Obedience Regulations. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available and the class has not reached its limit.

ENTRY FEES shall not be refunded if:

- A dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Trial Committee.
- if the trials cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause which is beyond the control of the Club or show committee after the closing date of the trial.

ANYONE IN NEED OF SPECIAL ACCOMMODATIONS OR SPECIAL ARRANGEMENTS should contact the Trial Chairperson by telephone or in writing in advance of the trial.

NO PRACTICING in rings at any time.

ZERO TOLERANCE: EXHIBITORS who do not clean up after their dogs will be excused from the trial. In such cases, no refunds will be made.

THE TRIAL COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this event.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called.

ALL DOGS PRESENT must be held on a leash or confined to their crates except when being judged. Due to space limitations, only dogs that belong to competitors or people working at the trial will be allowed to enter the building.

Any exhibitor, dog or child that engages in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. No refunds will be given.

PROHIBITED FROM THE TRIAL SITE are puppies under 6 months of age, pinch/prong and electrical collars (dummy or not), head halters and special training collars. The site will be monitored, and offenders may be asked to leave. In such cases, no refunds will be made.

No dog may enter the ring, for either judging or awards, with prohibited equipment. Nothing may be hanging from the dog's collar.

Dogs may not be left in cars without proper ventilation or air flow.

MOTOR VEHICLE ENTRY WAIVER: ALL PERSONS attending this event hereby waive any claim for damages against Mohawk River Obedience Training Club, Inc. or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.
