CONSULT JUDGING PROGRAM FOR TIME OF JUDGING. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. Judges are not required to wait for dogs. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is being judged.

AKC RULES APPLY for class size limits, **8 hours of judging per day.**

Space for un-entered dogs will not be provided at this trial.

All dogs present must be held on leash or confined in their crates except when being judged.

Jump Heights and Running Order: We have requested your jump height for obedience (and rally) classes which include jumping exercises.

This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

First entry of each dog-obedience trial- (includes AKC recording fee & event fee)	\$25.00
Second entry of same dog -obedience trial- (includes AKC event fee)	\$20.00
Non-Regular obedience classes-obedience trial- (includes AKC recording fee & event fee)	\$25.00
First entry of each dog-rally trial (includes AKC recording fee & event fee)	\$25.00
Second entry of same dog-rally trial- (includes AKC event fee)	\$20.00

A Recording Fee of .50 cents for each dog and an AKC Event Service Fee of \$3 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (AKC rule Ch. 11 Sec.2) A \$3 AKC recording Fee will be required for each entry in Rally (AKC Rally Regulation Ch. 1, Sec. 3). These fees, paid to the AKC, are included in the entry fees.

Do not staple check to entry. Confirmation of entries and judging schedule will be made after entries close. OVERNIGHT ENTRIES, PLEASE CHECK “NO SIGNATURE REQUIRED”! Entries not on official AKC entry forms and photocopies of entry forms without the agreement and instructions on the reverse side of the form are **NOT ACCEPTABLE.** No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. **Returned checks** do not constitute a valid entry fee. The Trial Secretary will add a collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitor may result in being put on a cash basis.

ERRORS ON ENTRY FORMS-Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellations of entries after published closing date.

No refund of entry fee will be given in the event that a dog is absent, disqualified or excused by a veterinarian or judge or barred from competition by action of the Trial Committee; or if it is impossible to open or complete the trial because of riots, civil disturbances, or other acts beyond the control of the Trial Committee.

BITCHES THAT COME IN SEASON after the closing date of entries may receive a refund, less \$5.00, if certification from a Veterinarian is received by the Trial Secretary prior to the start of the Obedience / Rally trial.

MOVE UPS will be permitted provided the maximum number of dogs per day for that judge has not been reached. The completed Move Up Form must be presented to the trial secretary at least 30 minutes prior to the start of each trial.

OBEDIENCE TRIAL HOURS are from 8:00 A.M. to 6:00 P.M. The show building **will not** be available to exhibitors on Friday prior to the trial.

LIMITED CRATING SPACE WILL BE PROVIDED INSIDE. Crates can remain in the building on Saturday night, but no dogs. All exhibitors must clean up after their dogs. Dogs may only be exercised in designated areas.

Exercise areas will be plainly marked **Please clean up after your dogs.**

This show giving club, the Show Superintendent, their agents, employees, etc. assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, their dogs, or property and further assumes no responsibility for injury to children.

All dogs present must be held on leash or confined to their crates except when being judged. Indoor space for crating of entered dogs is available. Exhibitors and handlers will be responsible for clean conditions in and around their dogs' crates.

From **Greenville, SC:** Take I-85 North to South I-485 (exit 30) towards Pineville. Take I-77/21 South (exit 67) towards Columbia. *Note on I-85 the exit numbers will decline to 0 then start at 67 at the I-77 exit.* On I-77 South, take exit 90 (Rt. 21 Carowinds Blvd.). Turn right onto Carowinds Blvd. and go 0.8 mile to Choate Circle (3rd stoplight). Turn left onto Choate Circle and go 1.7 miles to the show site on the right.

From **Virginia/Raleigh:** Take I-85 South to I-77 South to Carowinds Blvd. Exit. Then follow the Greenville directions.

From **Columbia, SC:** Take I-77 North to Carowinds Blvd. Exit. Turn left and follow the Greenville directions.

OFFICIAL OBEDIENCE ENTRY FORM

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.**

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.

3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3. of the *Rules Applying to Dog Shows*.)

4. Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
