DON'T FORGET THAT THERE ARE FOUR OBEDIENCE & FOUR RALLY TRIALS. If you enter one regular class in all four obedience trials, your entry fee would be \$25 per trial for \$100.00. If you enter the same dog in more than one class in one trial, the highest priced class is considered the first entry, so if you enter the same dog in two regular classes, your fee would be \$43.00. The Obedience Trial and Rally trial are two separate trials. If you enter the same dog in one regular class in obedience and one class in rally, your fee would be \$25 per trial for \$50.00

ENTRIES

- Entries must be submitted by mail on official AKC entry form or thru Showentries.info. <http://showentries.info/jotc/>. Payment for on-line entries will be received through Paypal. A \$1.00 service fee will be added per class per dog entered.
- Entries must be complete, including signature, jump height, and proper payment of entry fees to be considered a valid entry.
- An e-mail notification will be sent when your entries are received; after entries close, official confirmations, including armband numbers, judging program, etc. will be sent via e-mail. Please configure your e-mail software to allow receipt of information from jotctrials@yahoo.com. If you wish to receive conformation via US Postal Service please include a stamped self-addressed envelope with your entry.
- A Refund of entry fees for bitches entered that come in season after closing date of this show may be obtained by sending a veterinarian's certificate to the Trial Secretary. This certificate must be postmarked before the opening day of the show or given to the Trial Secretary before the start of the show.
- Changes, additions or corrections to entries must be received in writing or by email prior to close of entries.
- There will be no refund for duplicate entries
- RETURNED CHECKS do not constitute a valid entry fee. The Trial Secretary will add a \$30.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

LIMITED ENTRIES (8 hours per judge)

Entries will be limited in accordance with Chapter 1, Section 27 of the AKC Regulations. Each judge will be limited to a total of eight hours of judging time per day. Entries will be processed in the order received and time limits calculated for each judge until the 8-hour per day judging limit is reached or entries close. Obedience UDX Class and Rally RAE Class entries will be given priority.

TRANSFER BETWEEN CLASSES

Transfers between classes within the same trial will be allowed. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Transfers between an "A" and "B" class at the same level are allowed.

- ◆ The Show Site will be available to exhibitors from 2:00 pm Friday and 7:00 am Saturday and Sunday. Dogs must be removed from the show site immediately after close of activities each day.
- ◆ Per Sections 1 & 2 of AKC's Dealing with Misconduct, the Show Committees reserve the right to retain Show Committee jurisdiction over exhibitors whose names have been referred by hotels/motels as having left their rooms and/or grounds in a state that appears negligent or offensive. The exhibitor will be responsible for picking up after their dogs at the motels/hotels.
- ◆ Please bring waterproof covering to put under your crates.
- ◆ No dogs will be allowed in the restrooms by order of the Mississippi Fairgrounds Commission.
- ◆ Dumping of dog food into the restroom sinks or toilets is strictly prohibited, by order of Mississippi Fairground Commission.
- ◆ Exhibitors are responsible for picking up after their dogs on the Fairgrounds. Do not allow your dog to urinate/mark inside the building or on the front of the building.
- ◆ The Jackson Obedience Training Club assumes no responsibility for any loss, damage or injury sustained by exhibitors or to any of their dogs or property & further assume no responsibility for injury to children.
