The grounds are west of New Glarus, off of Rt 39 and Cty Rd J) **The OPEN All-Age Stake will begin on Friday March 25 at 8:00 am and run until conclusion and the AMATEUR All-Age Stake will start no earlier than 8:00 am on Saturday March 26 and run until conclusion. The puppy stake will start after the 2nd Series of the Open Stake on March 25 but not before noon. Chukars will be used for both the All-Age and Puppy Stakes.**
