One on Saturday April 16, 2016 and the other on Sunday April 17, 2016 in Mazomanie, Wisconsin on the Mazomanie Unit Lower Wisconsin Riverway Hwy Y Mazomanie, WI. **There will be an OPEN All-Age Stake and a PUPPY Stake on each day. The PUPPY stakes will start after the 2<sup>nd</sup> Series of the Open Stakes but not before noon. Chukars will be used for both the Open Stakes and the Puppy Stakes will be run on either chukars or pigeons.**
