Entry Limitations and Regulations

Combined entries for all classes are limited to 8 hours per judge each day. Transfers will be accepted at the trial per AKC regulations provided that there is judging time available. All classes will be run in **forward catalog order on Saturday** (ascending jump height, beginning with the lowest jump height entered for classes with jumps); and in **reverse catalog order on Sunday** (descending jump height beginning with the highest jump height entered for classes with jumps). Exceptions may be made in obedience for handlers with multiple entries.

Trial Entry Information and Trial Regulations

Entries are acknowledged via email as soon as they are received and processed. Please review and respond right away if any changes are noted. Armband numbers are confirmed and judging programs are distributed via email for all entries. This will be shortly after closing, when final judging assignments are complete, and exhibitor armband numbers have been assigned. Premium lists for future trials will also be sent out via email.

Refunds will be given for entries withdrawn in writing or via email before the closing date and time. SDTC will give a refund less \$5.00 for bitches that come into season after the closing date of the trial, and for no other reason. You must submit a signed statement of the dog's condition from your veterinarian on his/her office stationery along with your request for such a refund to the trial secretary at least 30 minutes before the start of the trial.

No refunds for errors on entry forms, or if a dog is absent, disqualified, or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.

Changes or corrections to entry forms must be received in writing or via email prior to the close of entries. Indicate '**UDX**' or '**RAE**' if you are entering both OB & UB or both AB & EB and you want no entry if one class or the other is already closed due to entry limitations (Obedience Regulations: Chapter 1 Section 27).

Obedience High Jump Height is required for all entries in classes with jumps. **Rally Jump Height** is required for Advanced and Excellent classes.

Entry Fees must be paid with entry submission for online entries. If a check is returned, we will add any bank fees to the amount due.

Transfers will be accepted per AKC regulations if you have earned a new title after closing, and if the class is not full. The fee difference will apply for transfers from a non-regular to a regular class. Completed and signed transfer form must be submitted to the Trial Secretary no later than **30 minutes** prior to the start of judging for the trial.

Show Site will be open for setup from 5:00-8:30 pm Friday. Show hours are 7:00 am - 4:00 pm Saturday & Sunday. No overnight parking; no dogs may be left in the building overnight.

All dogs present must be held on leash or confined to crates, except when being judged or in designated warm-up areas. No Flexi leashes or prong collars permitted in the buildings. No ex-pens permitted in the buildings. Exhibitors and handlers will be responsible for clean conditions in and around their dog's crate.

SDTC assumes no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. For safety reasons, no strollers are permitted in the building during show hours.

Savannah Dog Training Club, Inc. reserves the right to remove any animal in distress from a parked vehicle or crate, and all persons attending this dog show shall hereby waive any claim for damages against the club for such removal.

- Run throughs will be allowed by **pre-registration ONLY**.
- Run through registration closes when the trial registration closes- 6:00pm on 6/8/16 or when run throughs fill, so sign up early!
- Novice, Open and Utility- \$10.00 per dog, maximum 10 minutes ring time.
- Novice limited to 27 runs, Open to 24 runs, Utility to 21 runs.
- Rally/Beg. Novice- \$10.00 per dog, maximum 10 minutes ring time (Rally courses will be nested).
- No food permitted in the rings, no harsh corrections.
- There will be no prizes, ribbons, scoring or placements.
- Handlers may perform a run through or practice selected exercises within their block of time.
- Group sits and downs are included at no extra charge for dogs signed up in the Novice or Open ring. Group exercises will be conducted after each 8 dogs.
- Jump height is required for Open and Utility. Dogs will be assigned ring time in descending jump height order.
- Ring times in Novice and Rally/Beg. Novice will be assigned as the entries are received
- We will accommodate for multiple entries and late arrivals as time allows.
- SDTC members will steward the rings and conduct run throughs as requested. SDTC members will do their own ring time separately, prior to start time.
- Entry fees will be refunded if run throughs fill. Run through schedules will be emailed after the closing date.
- **THE GYM MUST BE EMPTY OF PEOPLE AND DOGS BY 8:30PM ON FRIDAY**

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.

3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. 4. Dogs listed in the AKC Canine PartnersSM Program may be eligible to enter all-breed AKC Obedience & Rally trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
